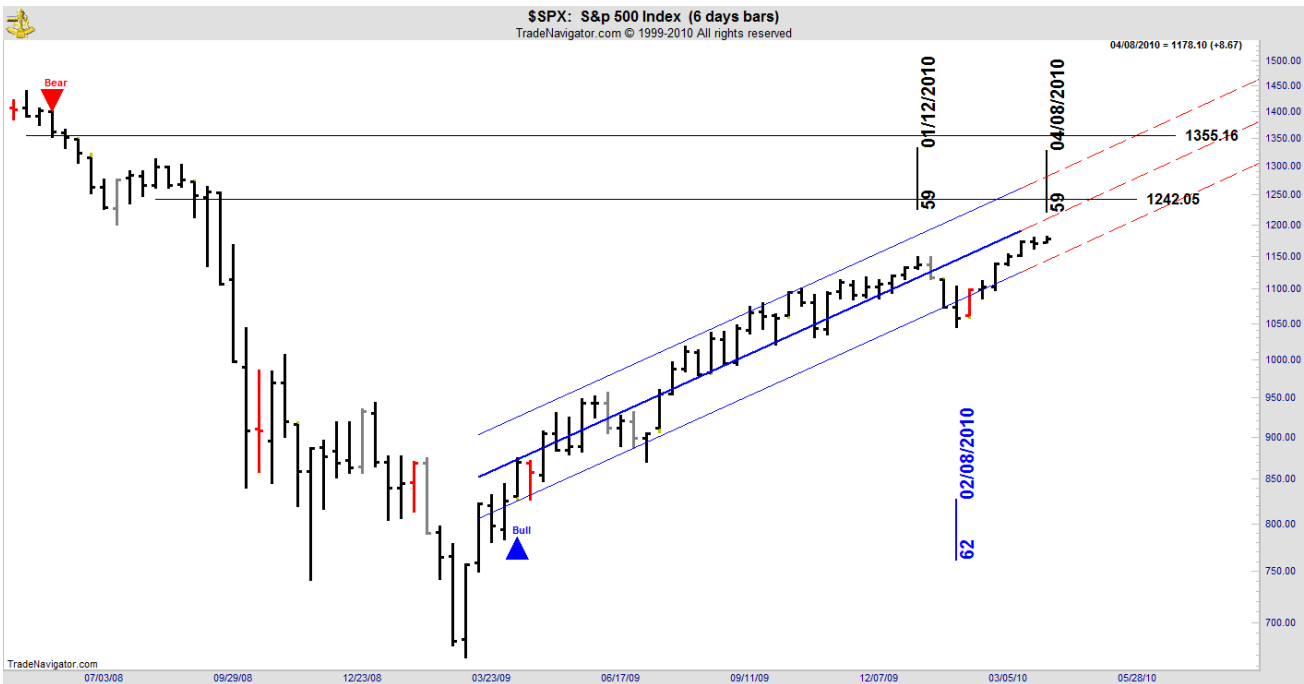

 On 24 Day Regression Channel, Trend is: UP



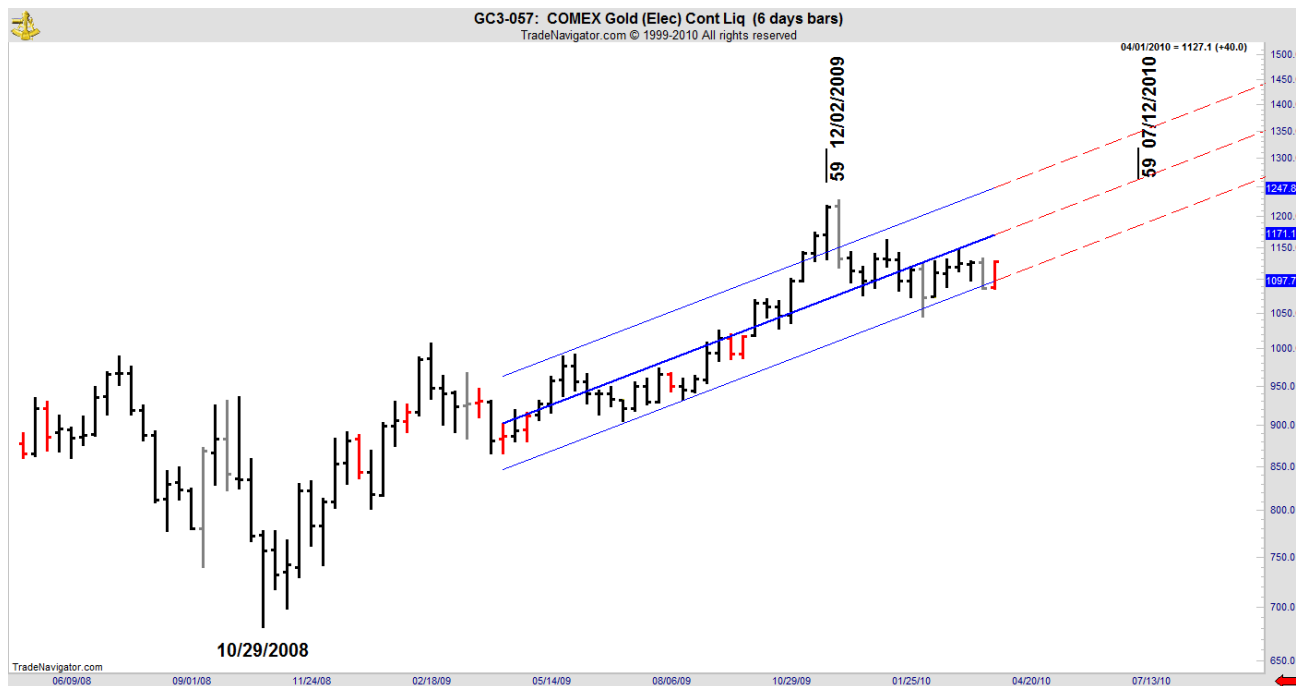
# Gold

On 6 Day Regression Channel, trend is: DOWN

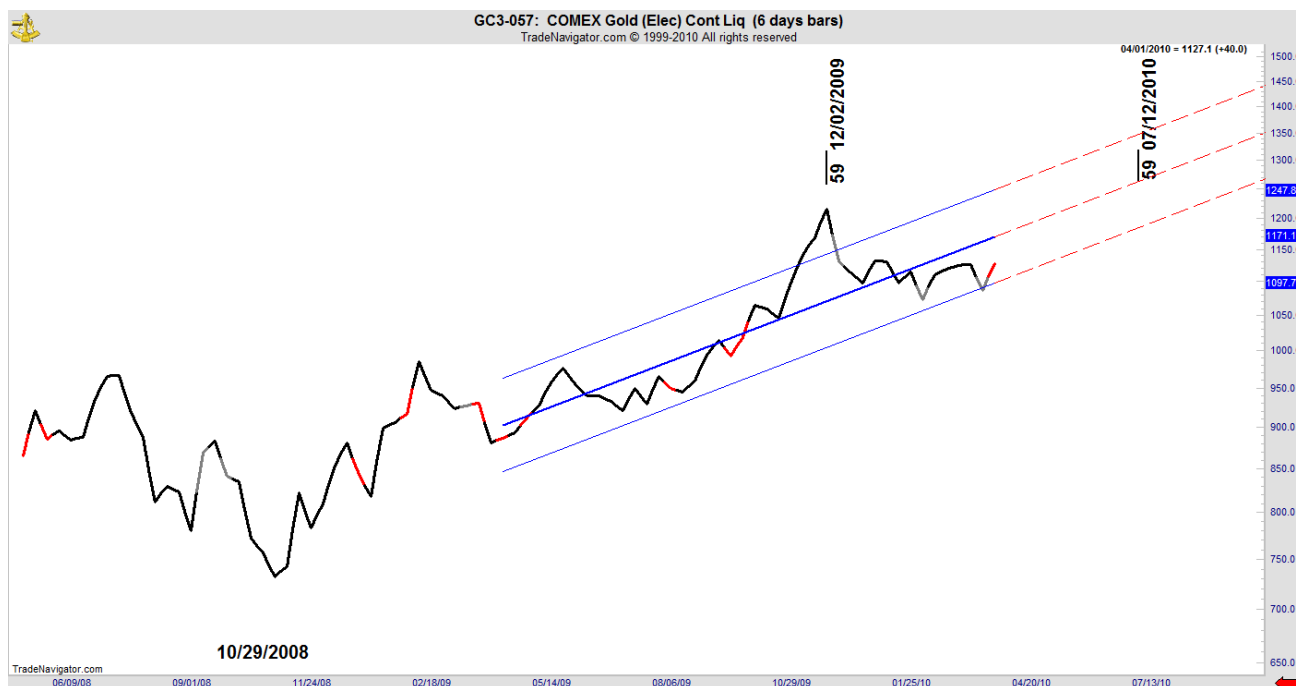
On 12 Day Regression Channel, Trend is: UP

Comments/Prop Trend Signals: Gold has made a conditional Sell signal on the 12 day chart. Break of the regression channel support will target the 1037 zone.



See how Gold is working the regression channels on the “close only” chart below, and fighting to hold the lower channel. Do you still think markets are random?

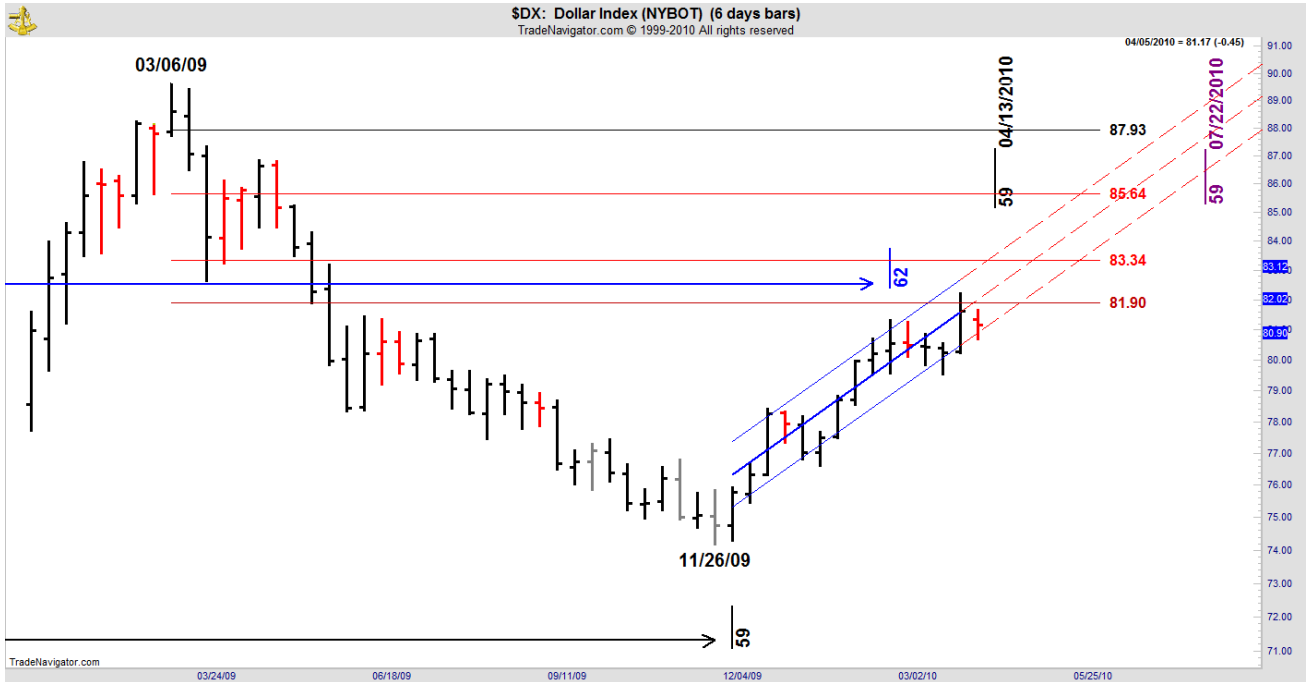


# US Dollar Index (DX)
